Um, Dr. Palevsky is a New York State Licensed pediatrician. And he has been practicing medicine for 35 years. He was also a past president of the American Holistic Medical Association. That's right, isn't it? That's correct. Can you give us a little bit of your working background prior to

COVID. So thank you for that introduction. I graduated in an American medical school at NYU New York University Medical School in 1987. And I did a regular pediatric residency at the Mount Sinai Hospital in New York, from 1987 to 1990. And then one year of a little extra fellowship training in outpatient and emergency room pediatrics. And for the first nine years

after I finished my training, I worked in a pediatric emergency room, I ran a pediatric intensive care unit, I went to high risk deliveries, I took care of very sick newborns in the neonatal intensive care unit. I worked on the inpatient Ward, with residents and medical students taking care of hospitalized children. I taught medical students and residents in other areas of the department. I had a clinic of my own on the affiliated with the hospital. And then in the year 2000, I started working in private practice doing what's more, what's pretty much named a holistic, integrative Pediatric and Adolescent practice. And I've been doing that for the last 22 years or more.

Okay, great. That's, um, it's a great background. And it's, it's, I'm very soon talking to you, because I feel like you've got that, that to overview of what's been happening in pediatrics for 35 years, and you've got that emergency background as well as private practice. So that's, that's gonna be great for our questions. thank you. Are these COVID-19 gene therapy vaccine safe and effective for children of any age? In your opinion?

Well, the first problem with answering a question like that is these are not vaccines. And when you look at a product that they're calling a vaccine, one needs to ask the question, what technology are they using in these injections? And has that technology ever before been used in a vaccine at all? And the answer is no. So not one of the technologies of these so called COVID injections, has ever been used to reduce an infectious illness to protect you from an infectious illness for to reduce any death from an infectious illness. So in order to understand whether this technology is effective as a vaccine, we usually need 710 or even up to 15 years worth of research as to whether or not this specific technology functions the way we need a vaccine to function, which is to protect you against an infectious illness, to reduce deaths, to reduce hospitalizations, to reduce severity of illness, to stop you from carrying the virus and to stop you from transmitting the virus. And when this injection came out, the people who were in charge of selling you this injection actually told you the following. We don't know if it'll give you an antibody against the virus. We don't know if it will protect you from getting the virus infection. We never even tested whether or not in the trials, it reduced severity of disease. It reduced hospitalization, or reduced death. We don't know if it'll stop you from carrying the virus, and we don't know if it'll stop you from transmitting the virus, by definition, they told you, we don't know if this will function as a vaccine. Here we are about 16 months later. And we still have the same statements to say, this injection does not necessarily give you an antibody against the virus, this injection does not necessarily protect you from getting the viral infection. This injection does not reduce severity of illness, and it does not reduce death from an infection. And they tell you point blank, this injection does not stop you from carrying a virus or transmitting the illness from one person to the next. So by definition, this is not a vaccine. And so what is it? You stated in your question? Because you may have been one of the few in the world who've actually read the patent from the companies who made these injections. They call it a gene therapy. They call it an operational system. There are even colleagues of mine who found information in the patents, where they call it a bio weapon. And here we are in April of 2022. And in November of 2020, I was asked in an international podcast, what I thought of this

upcoming injection, and I called it a murder weapon. And over the last 16 months, we have watched this injection kill hundreds of 1000s of people. And we have watched every authority who controls the narrative tell you that no one is dying at the hands of this injection.

That said, what we're seeing in pediatrics, what we're seeing in children is very, very concerning. We are seeing adolescent boys have 1000s of a percent increase in developing inflammation of the heart and permanent heart damage. We are seeing children get strokes and heart attacks. And we are watching the medical system. And the governmental media systems reduce just completely take that narrative and make it normalized. In other words, children get strokes, children get heart attacks, children get myocarditis. And we are watching them completely negate the fact that these shots are contributing to massive numbers of injuries in the pediatric population. We are watching newborn babies develop strokes and blood clots at the hands of mothers who have gotten the shot during pregnancy. And we are watching the neonatologist normalize strokes and blood clots in newborns, I worked in a neonatal intensive care unit for five years, I will tell you that seeing strokes and blood clots in newborns, was very rare. And now that it's happening more often, we are being told that it's normal. We are watching men and women who are trying to get pregnant, have trouble with their fertility at the hands of these injections. And we are watching hundreds of percent increases in miscarriages in women who have either had the shot or who have been exposed intimately to others who have had the shot. And again, we are watching the governmental narratives and the medical systems deny that any of this is happening. And let me just say that I have been watching parents for more than 30 years, speak about their experience at the hands of a medical procedure or a medical intervention. And I have watched the medical system tell them that their experience didn't happen. And we are watching that happen exponentially. Between 2020 and 2022. Yeah,

I tell you what I kind of feel like we are paying the price eyes as a community for not having stopped that gaslighting in the past and now it's happening on steroids that after speaking to Mary Holland and Barbara I feel like you know, because they're they were fighting the older vaccine war. And you're talking about gaslighting in general, I guess. But I feel like we're paying the price for not having stood

up. Right. That was That's well said. I met Barbara loe Fisher in 2003. In person, I met her in 2000 at a conference, but I met her in person in 2003. And I have heard the stories before I knew that there were stories. And when people have asked me, Why do I think this is going on? This is what I've said, for over 60 years, parents have been screaming at the top of their lungs, that their children have either died, or have been maimed or severely injured at the hands of childhood vaccinations. And no matter how loudly they screamed, no matter how loudly they spoke, they were gaslighted. They were told no, you don't know what you're talking about. No, that doesn't happen. No, the shots don't do that. No, the studies say otherwise. No, the doctor

said that's not possible. No, my sister is a doctor. She says no, that's not possible. And the thing is, is that Congress heard the stories, the media heard the stories, the medical doctors heard the stories. And for whatever reason, it wasn't loud enough. And so now, what we're seeing is the true sacrifice of children in the world. And what we're seeing is parents who are blindly going to have to scream so loudly, after blindly giving up their child to these authorities, because there's a blind trust. And if you ask any of the mothers and fathers and grandparents and aunts and uncles and cousins of these families where the kids either died, but were severely maimed. They will tell you that no one listened to them. They will tell you that they thought vaccines were safe. They will tell you that they knew not to question or ask about safety. And even if they were asking about safety and questioning, they allowed the doctors to say to them, don't worry, they're safe. We wouldn't do anything to harm your child. And they went ahead and gave their children the shots. And the doctors, even if they said, Yes, we think this shot or the shots hurt your children. They would never write it in the chart. And they would never testify publicly that those shots injured or killed those children. And so the parents who watch their kids either die or get named, walked in with a trust. And they had to deal with the tremendous guilt, shame, anger, pain, regret, failure that went along with trusting and not having done their own homework. And so here we are today. And as you called it, it's on steroids. We're going to watch unfortunately, parents surrender their children, to these authorities, and it's gonna get loud, Elizabeth, and it's gonna get loud, because they're going to turn around and say, Why didn't we know? Why didn't we know. And I think the greatest part of this war, which to me, has always been about a spiritual war is the fact that we have been worshipping false gods and false idols for far too long. And they come in the form of the media, of social media, of royalty of Hollywood in America, of doctors, and of scientists and the government

And what we're finding is that this is a spiritual war where we need to return to our inner authority, we need to remember where our trust comes from, and where our intuition drives us, and messages us, and where that information truly comes from. Now, whether you call it God, or the universe or spirit, or a higher power, to me, it's all in one in the same. But we have forgotten the laws of nature, we have forgotten the laws of God, we have forgotten the laws of the universe. And we have outsourced much in the way the people on earth did before the flood that took out the entire world's population, except for Noah and his family and the animals that he put on the ark. And so we are rekindling history. And we are finding that we may not get a flood as God had promised us do to the rainbow that we would not get another flood. But it's very likely that this this volume is going to be so excruciatingly loud when we realize not only what we're doing to children, by giving them this shot, which is not a vaccine, but by what we've been allowing ourselves to do to children for decades, by giving them any of the childhood vaccines. Because when people really start to learn that the childhood vaccines have never been studied for safety. And that the ingredients in the shots have never been evaluated for injection into the human body to see what they do once they're injected into the body. And that every company that makes these shots, has full immunity to any liability for any wrongdoing, for any contamination for any killing that they engage in. And that these companies that are making the shots before 1986, were getting their butts whipped in court, with millions of dollar payouts for damages regarding their childhood vaccines that were hurting and maiming and killing kids. And that hurting and maiming and killing didn't just stop just because the United States government took away the majority of their liability. They're hurting and maiming and killing continued.

It didn't just go away. We just stopped talking about the fact that so many kids were being hurt and maimed and killed before 1986 That they were losing so much money in the courts. Because damages were so high based on real time cases of them being found guilty of maiming and damaging kids. And that didn't stop just because the United States government passed the law, removing the most of their immune most of their liability. And it certainly didn't change in 2011 when the Supreme Court ruled that vaccinations are unavoidably unsafe, and essentially removed the last vestiges of any liability that the vaccine manufacturers would have. And so what's going to get loud is how much the United States people and the people around the world turned their backs and turned a blind eye to what we allowed to happen. We allow these companies to make billions of dollars on products that they never tested for appropriate safety. We kept buying products from companies that were paying out millions, if not billions of dollars in fines before 1986. We kept buying products from those companies that did nothing to change any of their manufacturing products after 1986 and we kept turning a blind eye to the screams of the mothers to the screams of the fathers and to the screams of the babies and children who have been permanently damaged from the effects of the ingredients in the injections. Now in the in the United States. AIDS. We have one in five children with neurodevelopmental disabilities. We have one in 44. Children with autism. Yeah, we have an that was one in 10,000 in 1980. Yeah, that's really important that comparison, but we have one. And it's not because we're better at diagnosing it. Yeah, that's not true. We have one in 10 children with a DD ADHD. We have one in 20 children under the age of five, who have seizures. Something is happening to the brains of our children. And when you ask a pediatrician, excuse me, do any of the vaccine ingredients enter the brains of our children and inflame their brains causing any brain injury or damage? One of three things happens. One, they tell me I'm a conspiracy theorist. Or I'm anti science. Even though the basis of science is asking a question to they start to argue with me. Or three, they walk away. But the bottom line is they have never answered my question. Do vaccine ingredients enter the brains of our children. And I had been watching the health of vaccinated versus unvaccinated children for over 20 years. And I will tell you that the children who are unvaccinated don't have one in five with neurodevelopmental disabilities, or one in 44 with autism, or one in 10 with a DD and ADHD, or one in 20 under the age of five with seizures. You just don't see that in the unvaccinated children. And we have studies that demonstrate the truth of that.

And as a result of that study being published, yeah, we tell you that study could not be challenged. It was airtight in its methodology, in its statistics in its analysis, and its conclusions. And as a result of that study, the medical board in the state of Oregon and the United States suspended Paul Thomas's medical license. Ah, so because he told the truth. And he showed that vaccinated children are across the board healthier. And so

do vaccine ingredients enter the brains of our children? The answer is anyone who can read a dictionary who can read a package insert. Anybody who can read basic scientific studies can tell that the ingredients that are in shots directly allow for the ingredients in vaccines to enter the brain and cause brain damage. aluminum, aluminum is a nanoparticle. And it's the adjuvant in the bacterial vaccines. And aluminum as a nanoparticle can enter the brain. And aluminum is a non essential mineral, which means the body doesn't need it, and function and no study has ever identified or traced what happens to the aluminum nanoparticle. Once it's injected into the body. Where does it travel? Does it get into the brain? Does it get into the liver? does it damage the pancreas does it get inside the cells? And yet, the science of nanoparticles is very clear. nanoparticles can pierce the blood brain barrier and get into the brain. And the tragedy about this Elizabeth is that the bacterial antigens, the pieces of bacteria that are in the bacterial vaccines have to bind very, very A tightly to the aluminum. And so if you're going to get the aluminum passing across the blood brain barrier into the brain, it's going to carry with it the bacterial pieces and the bacterial antigens. And that's the danger, not just the aluminum, but anything that attaches to the aluminum in the injection that can potentially cross the blood brain barrier. It's going to cause brain damage, whether you see the effects of it or not. And that's the problem. Okay, is that brain damage is happening as long as aluminum can get across the blood brain barrier, which it can because it's a nanoparticle brain damage will happen, even if you don't see it, in obvious symptoms in the kids.

Well, again, the lipid nanoparticle and, and I first heard in 2020, that lipid nanoparticle was one of the ingredients in the injection. All I did was go into PubMed, which is the research arm of, of our scientific literature. And I typed in lipid nanoparticles. And I found the first article that popped up was the dangers concern concerning the use of lipid nanoparticles and its relationship to the male and female reproductive systems. And in the article, the author's make mention of how lipid nanoparticles through history, have been known to cause damage to brain, heart, lung, kidney, scan, blood, and male and female reproductive systems. So they also go on to say that these lipid nanoparticles have never before been used in vaccines. So essentially, there's no safety profile, to understand what happens biologically biochemically to the body once these ingredients are injected into the body. And so when you hear your outsourced authority, who you're just listening to with bated breath, tell you these shots are saved. You're being lied to. Because if you do your own research, you will find that the ingredients in the shots, which are not completely listed on the package inserts are not safe, cause major damage and have not been tested for safety in the shots. And so when you create enough fear, you reignite people's old traumas. And so they are not going to be able to look with discerned I added authority, and be able to see whether or not that authority is doing right by them, because they're back in their trauma from early early on in their lives. And they're not in their adult, they're in their child. They're in their old early childhood trauma. And so they, as we know, having having done pediatrics for so many years, and worked in inner city hospitals in New York, when you're dealing with children who have been abused, neglected, violated, raped, molested, physically beaten. The pattern is that they always want to go back to their parents in hopes that the parents would love them properly the next time. And so, when you're looking at a combination of fear, and the reigniting of early childhood trauma, it's almost impossible to get a person to stay in their adult and say, Wait a second, I got to think this through. I have to analyze this. I have to really wonder whether what you're telling me is right or not. The Child Trauma would basically turn around and say I have to believe you're telling me the truth. Because that child in me, will be mortified if you're not. And so I can't revisit those early childhood traumas, again, of being lied to, and beaten, and violated. And so it's a very, very straightforward propaganda and intervention, to get people to completely just believe, whatever they're being told, unless you've done your work on your early childhood trauma, and

you look at your authority and say, You know what, I need to question you about this, or I'm not going to just blindly get on this train, that you said, you're taking me to some Promised Land, when in fact, I'm not so sure that that's true. But what we have Elizabeth is a massive psychology in the world that truly believes that they would never do anything to harm us.

They were getting inflammation of intestinal organs, of abdominal organs of joints of the skin, legs and the arms. And because everything else was COVID, the medical community decided that these multi inflammatory system conditions must also be caused by the virus. And we were seeing populations of PDF children who are getting this nasal swab and because the doctors were utilizing nasal swab, as the, you know, definitive way of understanding if this was the viral load Listen, only 50% of the kids even had a positive nasal swab. But yet, even though their swab is irrelevant, but they weren't even looking at the fact that 50% of the kids had a negative swab test,

So I've got now I've now got questions that mis I mean, I know there weren't a lot of cases, but it's actually not. It's not a nice disease to have. You're saying it's caused by poisoning any idea where the poisoning is coming from?

Well, I'll tell you that in in April of 2020. I had a child in my practice two and a half years old, who fell in a puddle on the street in New Jersey. And within a couple of days, started developing very, very high fever. Okay, the fever lasted for seven days. She developed swelling of her thighs, hot red skin. And as the fever progressed over the days, the swelling descended down the leg, both legs, there was no other symptoms anywhere in her body, no respiratory symptoms, no intestinal symptoms, no urinary symptoms, just the skin and the swelling in the lower extremities. And as the fever progressed, what was red and swollen at the top of her thighs disappeared, only to be replaced by red and swelling, lower down the leg. And each day progressed down to the feet. Now I sent her for a cardiac echo. And her Echo was normal because at that time, we were worried that kids were getting something called Kawasaki disease, which is a dilation of the coronary arteries. So swelling of the coronary arteries. And she was the only person in her family that got sick. Our older sister did not get sick. Her mother did not get sick. Her father did not get sick. Her babysitter did not get sick. Her family members who saw her did not get sick. And all she did was fall into a puddle on the street. Now, over the two years, there are people who have been concerned that material has been coming from the sky that is poisoning us air pollution and things in the air. I don't know what was in that puddle. But I remember saying to the parents in April of 2020 It's got to be from the puddle because no one else in the family is sick.

I never had her tested. Okay, never had her tested. I sent her for the cardiac echo. Yeah. And as I do a lot in my practice, I work with other practitioners. And I had her see the acupuncturist, who with whom I've been working for over 20 years with children. And we both concluded that this was some kind of poisoning, some kind of multi inflammatory syndrome that looks like a clinical condition called serum sickness. And serum sickness usually happens in response to one or more chemicals that the body was exposed to, that caused a very, very strong immune reaction to fight it. And that's what multi system inflammatory syndrome appeared like. And she had no respiratory symptoms at all. And a lot of kids who are getting multi system inflammatory syndrome have no respiratory symptoms at all. And yet, what are we calling this SARS Severe Acute Respiratory Syndrome. And that's not what we were seeing in pediatrics. So I'll review. This is not even the adults who are getting sick. We're not getting an illness that looked like a viral illness. You have to know why does that patient have a low oxygen content? It's either because there's something affecting the lungs, or there's something affecting the blood. And because the carbon dioxide was normal. We were concluding very early on in March, April and May of 2020 that there's something happening to the blood of people who are getting sick. Okay. And so, when I saw that this was truly a blood disorder and not a respiratory disorder, And then I saw that people were starting to get better with hydroxychloroquine. Yeah. One of the first things I asked was, Is this a parasite? Could a parasite be affecting the body? Because hydroxychloroquine treats parasites, yes. And we have wasted time trying to understand what really was making people sick. And that's when you start to see more of the global plan, the stuff that's going on in the world. And then you start to see that there have been governments and peoples all over the world for centuries, for centuries,

What was also very tragic was that the child had lost function of some of his pituitary gland. So we had to be on medication, because the pituitary gland was not functioning. And when I saw the baby, the parents weren't yet convinced or told that the shot may have impacted the health of this baby. And they really didn't want to know. When I saw the baby at two months, the baby was developmentally delayed. There was low tone in the legs, they when you picked up when I picked up the legs, they just fell down to the table. The baby also had something called Miss statments, which is a vibration of the eyes at rest, so it was just moving side to side at rest. And I could not get the baby to look directly in my eyes. Right? The giveaway here, I mean, I've had a little bit of involvement with this to give away here in Australia is once you put on remdesivir, which is an intravenous line in the arm, right? You they do blood tests every single day for five days, and they're looking at KIDNEY LIVER function. And then they make a decision after five days, whether they're going to go to 10 days, and we usually find that they're going to 10 days the patient will die. The kidney liver function, I've seen the blood test results, I've seen it change after two days. Correct. But they don't anyway, parents look okay, this is another nightmare. Something's happening. I noticed in America about parental consent for vaccination for children at school, there's been an attempt, I think, to allow children to approve, to sign up for themselves to have the COVID vaccine, and then the parents don't even find out that the child's

had the shot. So in in 2011, in 2021, was it 20, it could have been 2020, the District of Columbia, in the United States was arquing a bill that would essentially give doctors in schools,

the ability to vaccinate children are 11 years of age and up without parental consent. Right, not only would they be able to give children any childhood vaccine, but in the bill, the doctors would not be obligated to tell the parents that the shots were given to the kids. And that the parents would receive an explanation of benefits EOB from the insurance company about the visit. But the vaccinations would not have to be listed on the EOB the explanation of benefits, so the parents would not have to know about it, the parents would not know. Because the kids would be made afraid, essentially, to tell the parents that the kids got the shot. And if the child had a bad reaction, and the parent would be looking at the kid going, well, I don't know what's wrong, because we made afraid that bill was actually passed in the District of Columbia to allow that to happen. And earlier this year, in March of 2022, a lawsuit against the District of Columbia was one striking down that bill that would take away the authority of the schools and doctors to give kids vaccinations 11 years of age and up without parental consent. And without, I mean, it would be an overt attempt to hide medical care from the parents, essentially, the state would own your child. And you wouldn't know what the state did to your children. And the District of Columbia passed this. And it was it would it would set precedents for other states in the country. But in March of 2022, there was a lawsuit from I can decide.org Informed Consent Action Network. Yeah, I can decide that all that work in the lawsuit striking down that Bill, thank God for them.

Well, it's not the legislators doing it. You see, what's not what's not readily understood in in the in the world is that legislators are not being elected to represent the people. The legislators are bought by the special interests and the corporations to do their bidding. And it's been a long time, at least in the United States, where we've had a government for the people and by the people, because corporate interests have been running the United States for many, many years. And so that's how this happens. So no matter what you try, that's why for decades, parents had been screaming at the top of their lungs to legislators about the dangers of vaccines and the legislators just pass them by and legislate against them anyway, because they're not representing the people anymore. They're representing the special interests, who are either bribing them or manipulating them or both, to get them to do the corporate interests. And that's, again, that's another one of those, it needs to get really loud. for the public to understand what has been going on and what we've allowed to go on for decades, just like we have allowed companies that have been paying millions and billions of dollars for maiming and killing kids before 1986. Those same companies didn't change their safety profiles of their shots. And those same companies were being fined billions of dollars for improper studies on drugs that were killing people. And we kept buying their drugs. So how much louder? Does it have to get for people to realize that we have been complicit in this whole process, we have been purchasing products from the very companies that have been hurting us. And then more and more that they pay in fines, the more and more we keep going back and purchasing more. So it has to get really loud before people listen. And that's going to be an unfortunate ending. And I'll leave it at that.

And you went ahead and you did it anyway, that ladies and gentlemen is science, science is being able to take a neutral approach to something and come up with an outcome that may differ from what you previously thought. But be able to rely on that outcome. Because you have ownership of having thought it through, researched it, investigated it and figured it out yourself. And when we start doing that more and more and more, we will become an empowered world again, because there's the same when the people fear the government, we have tyranny. When the government fears the people, we have freedom. Yeah, that's
